**Policy, Procedures & Guidelines for Technology**

**School issued iPad:** The iPad is the property of Barnesville Public Schools ISD #146 and access to the technology provided by ISD #146 has been established for educational purposes as a means to prepare students.

**Student Expectations for iPad Use:**

1. I will take good care of my iPad, know where it is at all times and never leave it unattended.
2. I understand that I need to have my iPad charged daily, and will keep it in the school case at all times and away from food and drinks.
3. The use of my iPad is for educational purposes that are appropriate and conforms to District #146 policies, being responsible on the internet and not be hurtful or destructive to anyone

**Parent Expectations for iPad Use:**

1. I recognize that it is my responsibility to restrict access and help the school district in monitoring my child's iPad when outside the school setting and I will not hold the school district responsible for any such acts that are inappropriate.
2. In the event harmful or illegal material is found the parent and student will be responsible.

**\*\*The student issued iPad is subject to review and if necessary may be seized at any time The student and his/her parents should have NO expectations of privacy of materials found on the District issued iPad.\*\***

**Google Apps for Education:** Barnesville Public Schools utilizes Google Apps for Education for students teachers, and staff. Gmail, Google Calendar, Docs, Sheets, Forms, Slides and Classroom are all parts of the suite that teachers may use in his/her classroom. All students are assigned an email account and can only email and receive emails within our domain

**Internet Agreement:** The Internet is part of daily online activity that students will use while attending Barnesville Public Schools. There is a firewall that blocks any inappropriate sites while on school grounds but once students connect at home, parents are responsible for putting a firewall or blocking home Internet access Students in grades K-6 have additional security put on by the technology team at Barnesville Public Schools to help limit exposure. Students will use their iPads and Internet appropriately, and for school intended purposes. If a student fails to comply, the Internet may be limited, blocked or iPads taken away for a period of time (this includes inappropriate material and photos that may be downloaded onto the camera roll).

**Online/Media Publications:** Barnesville Public Schools may publish photos/videos of students in various school and classroom activities on the school's website and Facebook page. Be advised that no student names will be used, rather, just general descriptions such as sports teams, parties, etc.

**Barnesville Public Schools iPad Protection/Insurance Plan**

With the implementation of iPads in a digital learning environment ISD #146 realizes the need to protect and insure the investment in technology made by the District as well as by the Students/Parents. The following is an outline for each family's review regarding warranty, accidental damage, international damage and insurance.

For 2024/25 our district has approved a \$35 technology fee. This covers one breakage or incident that needs to be sent in for repairs. It also covers the 24/7 web filter that is installed on each iPad. If an iPad is sent in for repairs, that \$35 fee will need to be paid again to maintain coverage on the iPad.

2024/25 Tech Fee:                 \$35.00 per iPad with a family maximum of \$100.00  
(Special payment plans may be available, contact your building principal for details)

The \$35 fee is nonrefundable, and coverage begins when the tech fee is submitted.
